# Travis Says,

## SURFSIDE DEPUTY REPORT DEPUTY T. OSTGAARD

The following are the calls I handled for the week of April 10<sup>th</sup> to April 16<sup>th</sup>, 2014.

For the week I gave 7 traffic warnings and issued 2 traffic citations.

On 4/11 I received a call about a young male walking by himself in the area of 305<sup>th</sup> and O Place. I checked the area and did not locate anyone.

On 04/12 I was on routine patrol on M Place when I observed a male subject I knew to have two warrants for his arrest. I had passed the male subject and when I was turning around he ran off. I did not see where he went. I checked the area, but did not locate him. On 04/12 I was in the area of 300<sup>th</sup> and U Place when a resident advised me of a possible burglary in the 2200th block of 301<sup>st</sup>. I went to the house with the reporting party and observed a back window on the ground and the shed door open, but nothing appeared to be missing. The house was in very bad shape and a neighbor stated that the homeowner granddaughter had just been down. I contacted the homeowner by phone and she stated that the window had fallen out from rot and there was no burglary. She stated that she is putting the house up for sale and that there is nothing to take from the house.

On 04/13 I was dispatched to Oysterville beach approach for a vicious dog complaint. The reporting party stated he was at his residence on 340<sup>th</sup> Place. I contacted the reporting party and he stated that his wife had been walking their poodle on the beach near the North outflow and a black/white pit bull attacked her poodle. The wife stated that her dog and the pit bull were both off their leashes and the pit bull attacked her dog, biting it by the neck and dragging it on the sand. She stated that she kicked the pit bull and it let go of her dog. She stated that her dog then ran to the dunes and she followed it, so she never contacted the dog's owner. I checked the area for the pit bull, but did not locate it. On 04/13 I received two reports of shots fired from the area North of 320<sup>th</sup> and J Place. The person shooting had already called in to the dispatch to advise them he was target practicing. The area that the subject was shooting in is not in Surfside and he does shoot in a safe manner.

On 04/14 I responded with another deputy to the 31200th block of I Street for the report of a malicious mischief. Sometime during the night around 0300 someone ran in to a fence doing a significant amount of damage to it. The reporting party did not see the vehicle, but could hear it trying to get unstuck. On 04/14 I was on routine patrol in the 31100th block of I Street when I observed the same male with warrants from earlier in the week. I contacted the jail and confirmed they would take him on his warrants. Once I was advised they would take him I arrested the subject and booked him in to the jail.

**TENTATIVE SCHEDULE-SUBJECT TO CHANGE-WILL BE UPDATED AS FLUSHING SCHEDULE PROGRESSES**

The streets listed below will be highly susceptible to discolored/dirty water during flushing. Any part of Surfside could experience some low pressure during flushing. Elevated streets, such as J Place, are very susceptible to low water pressure during any water flushing. Please call if you have no water or very, very low water pressure. This could mean we shut the wrong valve or that the pressure in the system is dangerously low.

## ARCHITECTURE COMMITTEE REMINDER

When planning to build a new house, add an extension to an existing house, garage, deck, shed or fence, an approved application is required. The application must be completed prior to beginning construction. The form may be acquired from the Surfside Business office, when completed it will be reviewed by the Architectural Committee for approval. To speed up the approval process, the following information must accompany the application; The Division, Block, Lot numbers, and the physical address of the property. The type of material to be used must be on the application. A drawing of the lot, including lot dimensions, drawing of the item to be constructed, and the appropriate setbacks noted. If it is a new house; include two sets of floor plans, one for the county and one for Surfside.

**Remember~**

**A current 2014 Compactor's pass is required to use the compactor site!**

**Having trouble keeping track of your compactor pass? Here are some suggestions:**

- 1.) DO NOT dump your garbage on the way out of town, keep the pass at your home or in your RV. (part-time residents)
- 2.) Tie the lanyard to the garbage can in your garage. That way it's always where you need it.
- 3.) No garage? Hang it in your kitchen or next to where you keep your garbage.
- 4.) The lanyard can be worn. If you wear it then you won't lose it.

# Committee Corner

**To Surfside members from Larry Raymer, Chairman of the Tree, Brush, Vegetation and Noxious Weed Committee. IMPORTANT MESSAGE!!!**

**Beginning the first week in June, Pacific County will come to Surfside and assist with the removal of Gorse on your property for a bargain rate of \$55.00 per 1/2 hour minimum. Call me at 360-665-2685 if you're unsure if you have Gorse or Scotch Broom and I'll come take a look. Contact Jeff Nesbitt at Pacific County at 360-875-9425 (DO NOT CALL HIM REGARDING SCOTCH BROOM!) See Jeff Nesbitt's email to me below for details:**

Hi Larry,

The property owners will only be financially responsible for the time it takes me to walk in, apply herbicide to their gorse, and walk out. My field time is 110.00 per hour, with a 30 minute minimum. Administrative time, fuel, and herbicide will be provided at no charge. This deal only applies to properties with less than ½ solid acre of gorse. Most surfside lots are pretty small so the total cost will be \$55.00 for a good portion of the homeowners. Homeowners are recommended to pay by check or cash at the time of service, but we can also send an invoice in the mail.

To make my life easier you could emphasize to your members that Scotch Broom is not the same as gorse and that we are not able address the scotch broom issue at this time.

The best disposal method is to wait until the plant is completely dead (about a month after herbicide treatment), then cut them down, pile them up and burn them. TIPS: (1) To limit the chance of seed dispersal, burn the debris as close as possible to where it was cut. (2) Gorse has a very high oil content, making it very flammable, especially once it is dead and dry. Be very careful when burning. Feed the fire gradually, keep it small, have a water source and fire extinguisher within reach, and NEVER leave it unattended.



**FISHING RULES:**

We want to make sure that the kids have a great experience! To help make this happen and to ensure the safety of all, please obey the following Surfside Fishing Derby Rules:

- Help others who may not know how to fish.
- Obey the requests from Surfside Bridge Officials. They are there to help ensure your safety.
- **The use of corn is strictly prohibited – it kills the fish.**
- All fish must be caught during the Derby hours of 8:30-11:30. Return any carp to the canal.
- Adults are encouraged to help their child fish, but the child must be present at all times.
- No adult fishing until the Derby is over.
- For questions during the Derby, ask an official at the bridge or the Surfside Office. They're here to help you even if you've been in the derby or fished before.


