Now that the chipper site has closed for the season, we would like to remind everyone there is free mulch to pick up at the site in front of the fence. For those members who would like to take advantage of the free mulch, but do not

have a means to transport it to their property, we offer delivery for \$100 per trailer trip (each trailer contains approximately 6-7 yards of material). Please contact the business office to request this service. Also, we will have a "Rake Party" in the near future to help spread the remaining mulch over the Surfside property adjacent to the chipper site. Look for more information in a future Weekender.

PROPER MULCHING

Mulch is a newly planted tree's best friend because it:

- Insulates the soil, helping to provide a buffer from heat and cold.
- Retains water to help the roots stay moist.
- Keeps weeds out to avoid root competition.
- Prevents soil compaction.
- Reduces lawn mower damage.

Steps to Adding Mulch Around Your Tree

- 1. Remove any grass within a 3-foot area (up to 10 feet for larger tree).
- 2. Pour natural mulch such as wood chips or bark pieces 2 to 4 inches deep within the circle.
- 1. Keep the mulch from touching the trunk of the tree.

Tell me about RVs...

<u>RV Storage</u>

If you are renting a storage space for your RV at the Surfside HOA storage facility you will receive a statement for renewal by the end of this month. If you will not rent your space for the new year, please call or visit the office so we can list those spaces as vacant and available for other members to use. If you want to keep your space, return the invoice with your payment as soon as possible. RV gate keys for the new year will be available after November 1st.

<u>RV Use</u>

October 31st marks the end of the summer RV season. Unless your lot is exempt per the covenants, RVs must be removed by October 31st. In the winter, November 1st to March 14th, you can use a RV winter permit for up to 60 days. The winter permit is issued for up to 21 days at a time and cannot exceed 60 days total. While using a winter permit **you must be actively occupying the RV**, meaning you must be in it each night. No full-time RV residency is allowed on any lots. If you need a winter permit call or visit the office.

<u>RV Fines</u>

At the August 20, 2022 regular meeting, the Board of Trustees increased the fines for RVs left on lots during the winter season (November 1st – March 14th). If you receive a violation notice, you have 10 days to correct the violation by removing your RV from your lot. If not corrected within the 10-day timeline, fines will begin on the 11th day. **Fines start at \$25 a day for the first 30 days, then go to \$75 a day beginning on the 31st day.**

We need your help at the compactor site.

Vern, the compactor attendant, and other Surfside HOA employees, are working hard to help keep the site operating as intended, with as little cost to our members as possible. Please help them by remembering what trash is and is not acceptable.

We accept only household trash (this is typical "garbage," not carpet or construction materials). If you have questions Vern and company will be happy to answer them. And please remember, they have been trained on what is acceptable to put into the compactors and recycling roll-offs. If they say an item you bring for disposal or recycling is not acceptable, please respect their expertise and take the unacceptable item back home with you. Ultimately, all unacceptable items cost every Surfside member in dues, by increasing disposal fees and expending employee time. The compactor and the crew are a great asset to our community so *please*...help keep expenses low for everyone by being a responsible user of the compactor site.

> The disposal company, Waste Connections, which collects and dumps items from our recycling bins, will NOT accept dirty plastics. Dirty plastic ends up in the regular landfill. Please CLEAN OUT plastics and glass so they can be recycled.

The compactor is open: Mondays, 7 a.m. to 1 p.m. Thursdays, 12 p.m. to 6 p.m. Saturdays, 11 a.m. to 5 p.m.

PLEASE, be courteous and DO NOT leave your trash at the locked gate.

Going to the compactor? Don't forget your pass!

Peninsula Disposal, the vendor that picks up and empties our compactors, is now owned by Waste Connections and they do things a bit differently. Recently, they told our attendants the "blue bin" (right) can contain mixed recycling—plastics and paper. Only glass has it's own space in the blue bin. Please work with the compactor attendants to ensure we are using the blue bin as required. Thank you.



Washington Department of Fish and Wildlife approves three days of coastal razor clam digs beginning September 28

OLYMPIA – Washington Department of Fish and Wildlife (WDFW) shellfish managers confirmed today the first round of razor clam digging opportunities at Long Beach, Twin Harbors, and Copalis from Sept. 28-30.

"After taking a short pause to allow for more marine toxin testing, we're happy to report that razor clams on these beaches are safe to eat and pleased to get digging started," said Dan Ayres, WDFW coastal shellfish manager. "As usual, we'll continue to test and monitor the situation closely prior to all future planned openings."

The following digs during evening (p.m.) low tides will proceed as scheduled, after marine toxin results from the Washington Department of Health (DOH) showed razor clams are safe to eat:

- Sept. 28, Wednesday, 9:06 p.m.; -0.3 feet; Long Beach, Twin Harbors, Copalis
- Sept. 29, Thursday, 9:51 p.m.; -0.4 feet; Long Beach, Twin Harbors
- Sept. 30, Friday, 10:43 p.m.; -0.2 feet; Long Beach, Twin Harbors, Copalis

Marine toxin levels at Mocrocks beaches remain above the DOH's health guideline level. The DOH requires two test samples taken 10 days apart, must fall under the health guideline level before a beach can reopen for razor clam digging.

WDFW conducted summer assessments showing a strong razor clam population except at Kalaloch, which is closed for 2022-2023 season. More tentative dates are planned on Oct. 8-14, Oct. 24-30, and during November and December. The 2021-2022 season generated a record turnout of diggers and high number of razor clams harvested.



Not all beaches are open for every dig, so diggers are encouraged to make sure their intended destination is open before heading out. The most successful digging occurs between one and two hours before the listed time of low tide.

Digging is prohibited in the razor clam reserves, which are marked by 10-foot poles with signs. The reserves are located just south of the Ocean City approach on Copalis; and 2.8 miles north of the Oysterville approach on Long Beach.

The daily limit is 15 razor clams per person. Under state law, a daily limit consists of the first 15 clams dug regardless of size or condition, and each digger's clams must be kept in a separate container.



The next Quarterly Project Update will be held October 6th from 5:00 - 6:00pm via

Zoom. Join Pacific County staff and the project consulting team for a virtual public info meeting on the SMP periodic update process! The quarterly virtual public info meetings are a chance for you and other community members to learn about the project as it progresses and ask questions of SMP team members. The County's Planning Commission has started their review of draft amendments ahead of a public review process later this Fall. Pacific County is conducting a required periodic review of its Shoreline Master Program (SMP). In adherence to state law, the SMP is a comprehensive plan that guides the development, conservation, and restoration of Pacific County's shoreline. The purpose and scope of the 2022-2023 Periodic Review is to:

- Align the SMP with applicable state laws and guidelines in effect at the time of the review;
- Assure consistency of the SMP with the Pacific County Comprehensive Plan and development regulations; and
- Provide existing code clarifications to improve usability and predictability for applicants and reviewers.

ONLINE OPEN HOUSE—LEARN MORE & ENGAGE! Pacific County has launched an <u>Online</u> <u>Open House</u> to share information about the SMP Periodic Review process! Please continue to explore this new online community resource and learn what a Shoreline Master Program is, why it is reviewed, and learn about the review process. Additional details on draft SMP amendments will be available on the online open house in the near future.

Plan on installing a fence, a shed, a gazebo or building a garage or a house? REMINDER...

ALL building plans must be submitted to the Architectural Committee <u>prior</u> to any construction.

Pacific County will not approve permitting until the committee has signed off on all plans.

The committee meets every Tuesdays at 9 a.m. at the business office. The building packets are on our website at <u>surfsideonline.org/forms/</u> or you can pick them up from the business office. Applications must be received by end of day on Thursdays to make the agenda for the following Tuesday's meeting.

Please notify the business office if you want to attend the meeting in person.

If you are building on a vacant lot without an address, please post a sign so the committee knows which lot will be developed.

Two (2) sets of plans must be submitted to the committee. Once approved, you will get a copy of the approved plan. Take it to the county for their approval as needed. Surfside will retain one set of approved plans to keep on file.
